CORPORATE MEMBERSHIP TERMS AND CONDITIONS 2009/10

Rounds of Golf:

1. Unlimited rounds subject to max 1 tee-time per day (up to 4 players per tee-time), subject to availability.
2. No tee-times permitted Saturday or Sunday mornings
3. Additional rounds can be added at the current member's guest rate (max 8 additional rounds per day).

Company Golf Day:

1. All Company Golf Day bookings must be made through the Hospitality Department.
2. If the Company Golf Day is for more than 20 persons, the unlimited rounds cannot be used for extra guests, they will be charged for at the current green fee rate.
3. All food and beverages on the Company Golf Day, other than Coffee and Bacon Roll on arrival, will be subject to an additional charge, subject to 15% discount off published rates.
4. If the company holds an additional Golf Day the allocation of 1 tee-time can be used as part of the golf day.
5. Golf day must be used by the Corporate Member, cannot be transferred to any other company or individual.

Golf Reservations:

1. The corporate membership card is to be carried at all times when attending the golf club.
2. Corporate members are permitted to play Monday to Friday at any time and after mid-day on Saturdays and Sundays, subject to availability. Bank Holidays are considered to be a normal weekday.
3. Tee-time reservations can only be made by nominated contact at the company.
4. Corporate members can reserve tee-times up to one month in advance.
5. It is the responsibility of the Company to ensure that all golf reservations are upheld. Cancellations must be made, with the golf shop, prior to the reserved tee time.
6. Bowood Golf and Country Club reserve the right to charge at the members' guest rate for any unused tee-times not cancelled.
7. All players must register in the golf shop prior to play.
8. Any Day Account, set up at the beginning of the day, must be settled before leaving the premises.
9. Although Bowood Golf and Country Club does not impose a handicap restriction, we do require all golfers to have attained a suitable level of ability to play our championship golf course and have a good knowledge of the rules and etiquette. Inexperienced or non-golfers are welcome to use the Bowood academy course and driving range.

Other Conditions:

1. The Corporate Membership Card remains the property of Bowood Golf and Country Club. Loss or theft of the card must be reported immediately. A charge of £5.00 will be made for a replacement card.
2. Corporate membership cards are freely transferable for the use of clients or other guests.
3. Corporate members cannot maintain official handicaps at Bowood Golf and Country Club.
4. Tee-times cannot be transferred to other companies or used for play at other company golf days.
5. Membership benefits apply only to the company holding membership & cannot be transferred to any other company.
6. Annual membership year runs from April 1st to March 31st no refunds will be made for early resignation.
7. If the Corporate Member Company goes into liquidation or ceases trading all membership benefits are immediately terminated with no refund payable.

Rules and Bye Laws:

1. Bowood Golf and Country Club is a Proprietary Club, the Proprietor being The Marquis of Lansdowne.
2. Appropriate smart attire is requested at all times in the clubhouse and on the golf course. Denims, trainers, non-tailored shorts and collarless shirts are not permitted.
3. Players are requested to stay within the boundaries of the course.
4. Bowood Golf and Country Club is not responsible for any loss or theft incurred whilst on the premises.
5. Anyone wishing to file a complaint must do so in writing to the Proprietor.
